At present, there are no European Union standards applicable to the use of transparent bags/container in order to mitigate terrorist attacks.

Potentially, the reason behind such designs not being widely spread could be associated with the practical use and value added of such transparent containers.

While, it is true that the use of transparent disposal bins may offer a level of deterrent against placement of explosive or incendiary devices nonetheless,

such measures could only introduce an appropriate deterrent if all bags and articles (ex. cans and bottles) placed in the transplant bins would also be transparent.

Otherwise, the transparent nature of the exterior container would lose its intended purpose.

## Dear Claes.

I'm an Italian artist, we never met each other. In the last years I tried in my work to get rid of any mediation in order to mingle objects within the art space. Sometimes my work vanished in thin air and I was asked why not to embrace a voice. Still, what interest me are quantum elements that slightly differ from a given context, let's call it 1:1 scale interventions.

I'm writing you because I have an idea that involves one of your piece in the permanent collection at the MMK, Museum of Modern Art in Frankfurt: The Bedroom Ensemble, Replica I, 1969. The many stratification relying on your artwork triggers my interest. The Sidney Janis gallery art historical reference, the LA interior motel vibes, a bedroom in a Museum.

It is in the final context, the permanent MMK collection, where I think, the Bedroom Ensemble, gets to another level and here my reflection starts. In fact one nice happening takes place when the museum is closed to the public. It is about its cleaning, when the Museum takes care of the Bedroom. A cleaner takes care of an art piece that requires by its status the use of household appliances. A restorer being a motel cleaner, an art museum into a bedroom. In this moment different realities superimpose again. I wonder if you ever considered this aspect in relation to the Bedroom Ensemble.

Going back to my idea I'm interested in the specific cleaning moment of the Bedroom Ensemble. I would like to exhibit the cleaning tools used to dust the piece and ask the Museum to clean the bedroom one time during the duration of the show without any specific announcement but during the museum opening hours. I tried to get in contact with the conservation department and it seems complicated to convince an institution it is not a shame to show how an art institution takes care of its collected works.

I'm still wondering about the general idea and if I need a specific form for it so that in the meantime I wanted to share my thoughts with you.
